Andreas Tsouloftas is the Founder and Managing Director of Tsouloftas Constructions Ltd in 1980 and A.Tsouloftas & Sons Ltd. He graduated from the Civil Engineer School of the University of Manchester UMIST - United Kingdom in 1979. He is the MD of the Tsouloftas Group of Companies and associated Joint Ventures. He is Shareholder and Director of Limassol Marina Ltd and member of the Executive Committee. He is the President of Limassol Chamber of Commerce and Industry and also member of the Executive Committee of Cyprus Chamber of Commerce and Industry. He was the President of the Rotary Club Limassol-Amathusia and of Round Table Cyprus and of the Round Table no4 Limassol. He is President of the Limassol Police Friends Association since 2006 and member of ETEK since 1979 in Civil Engineering and of the Cyprus Association of Civil Engineers.



High Commissioner Madhumita Hazarika Bhagat is a career diplomat and joined the Indian Foreign Service in 1999. She has been educated in New Delhi and has done her graduation in Political Science (Honours) and followed it with an LL.B. She began her diplomatic career in the Embassy of India in Moscow, Russia (2001-2004) and thereafter, was posted to the Embassy of India in Almaty, Kazakhstan (2004-2006). She subsequently served as Under Secretary on deputation in the Ministry of Commerce, Trade Policy Division, New Delhi (2006-2008) with a stint as Deputy Secretary in the Public Diplomacy Division, Ministry of External Affairs, New Delhi. She was First Secretary in the Embassy of India, Stockholm, Sweden (2008-2011) for Commercial & Economic, Cultural and Information affairs. Later, she joined the Embassy of India, Moscow, Russia (2011-2014) in the capacity of Counsellor, Economic & Commercial and Culture. She served as the Deputy Chief of Mission in the Embassy of India, Ankara, Turkey (2014-2017). High Commissioner Madhumita Hazarika Bhagat was appointed as India's first National Coordinator and Joint Secretary for Shanghai Cooperation Organization (June 2017 - October 2019). She assumed charge as High Commissioner of India in Cyprus on November 11, 2019.
